*	The 'LMO Release into Environment' icon	Decision or risk assessment records	The icon indicates that the decision or risk assessment refers to an LMO for Intentional introduction into the environment.
Ð	The 'LMO for Food' icon	Decision or risk assessment records	The icon indicates that the decision or risk assessment refers to an LMO for Direct use as food.
當	The 'LMO for Feed' icon	Decision or risk assessment records	The icon indicates that the decision or risk assessment refers to an LMO for Direct use as feed.

	The "Alerts" icons	The top right corner of the page.	- The bell icons are a system notification that alerts users of all unread messages associated with their BCH account. The number in the red circle indicates the number of 'unread' notifications received.
			- Click on this icon to see all the messages and click on a particular message to see its details
	The 'language' icon	The top right corner of the page.	- Click on this icon to select one of the 6 UN languages. This will change the language of the BCH.
0	The 'black question mark' icon	The top right corner of the page	- Click on this icon to access contextual help articles associated with the specific page of the BCH you are currently navigating. Click on the title of the article to view the full text. You can also search for all help articles in the BCH.

2	The 'Chat' icon	The bottom right corner of the page	Click on this icon to chat with the Secretariat and ask for more information. They will respond as soon as possible.
0	The "information" icon	The Dashboard of the Submit page and on the Search page.	- Hover over this icon to reveal descriptive information about the respective item on the screen.
\checkmark	The 'down arrow' icon	Several places on the Dashboard.	- Click on this icon to expand the view. When expanded for a record type, it shows the 10 latest records created in the BCH.
+	The 'plus' icon	On the Dashboard next to a record type (middle icon).	- Click on this icon to open the online form where you can start creating a new record.
	The 'list' icon	On the Dashboard, next to a record type	- Click on this icon to open a summary page where you can view a list of all the associated records and their status for the respective record type
	The 'list' icon	On the User Dashboard page.	- Click on this icon to modify the role of a National Authorized User (NAU).
	The 'duplicate' icon	The summary of records page that is accessible through the Dashboard.	- Click on this icon to create a duplicate of a record.
	The 'edit' icon	The summary of records page that is accessible through the Dashboard.	- Click on this icon to edit a record.
